The 12th International Congress of Ecology Sponsor Form Terms

1. Exhibition Application

All sponsors to participate in the congress should sign the agreement. After signing the agreement, the sponsors are regarded as confirm to attend the conference and accept the agreement terms. The organizer has the right to refuse accept any exhibition applications from non-professional products.

2. Booth Allocation

The Organizer will allocate the booths according to the full-payment time and reserves the right to adjust the booths according to the exhibition hall or local government regulations during the exhibition. Sponsors shall not claim for compensation for such changes.

3. Exhibition Utilization

Sponsor can only display and / or sale products manufactured or distributed by the company or items or products with the legitimate right to sale in the allocated space. Unless otherwise formally permitted by the Organizer, the Sponsor shall not share or sublease the booth. And sponsors are responsible for damages of the exhibition hall, exhibition facilities and furniture provided by organizer and shall not make permanent change for furniture, vertical bar, column, floor or ceiling in or adjacent to the booth.

4. Payment Condition

The sponsor should transfer the total amount of sponsorship fee to the specified account with 10 working days after signing the agreement and forward the remittance note to derekli@healife.com by email.

5. Cancellation

Cancellation shall be made in writing. If the exhibitor informs the Organizer in written 45 days before the opening of the exhibition, sponsorship fee will be refunded after deducting 3,000 RMB as handling charge. If the written notification is provided within 30 days before the exhibition, 50% of the total cost will be deducted as a penalty. Cancellation made within 15 days before the exhibition is null and void and no payment shall be refunded. All payments shall be refunded in case the Organizer cancels the exhibition for whatever reason, including but not limited to force majeure, war, political issue or other unforeseen circumstances.

6. Change and Modification

In case the situation changes, the organizer reserves the right to change the venue and time and shall inform the sponsors 60 days before the opening ceremony of the conference. Such change will not affect the performance of this agreement. The Organizer is not liable for compensation to the Sponsor and shall not be responsible for any inevitable changes due to force majeure, natural disaster or other uncontrollable circumstances.

7. Booth Layout and Decoration

A standard booth includes booth area, three walls, socket, one information counter& two chairs, fascia board with English and Chinese company name and carpet. Exhibitor can decorate the booth according to the exhibition regulations and shall be responsible for any and all damages made during the decoration.

8. Exhibits Transportation

The sponsors are responsible for the exhibits and materials delivery to the exhibition hall and undertake the transportation and storage costs. Exhibits shall be evacuated in time as scheduled as all commercial wastes (including roll-up banner, KT board, product advertisement and printing materials) generated within the booth during the exhibition shall be taken away by exhibitors. Exhibitors shall bear extra cleaning fee (if any) of the booth and in case there is delay in booth removal, exhibitors shall be responsible for any compensation caused therein from.

9. Security

The sponsor shall keep all the exhibits properly and arrange adequate security measures during the exhibition to ensure the safety of the sponsors and their exhibits. The organizer shall not be liable for any loss, theft or damage to the valuable exhibits and personal belongings of the sponsors prior to, during or after the exhibition.

10. Hazardous Materials

The sponsor shall not take any hazardous material into the exhibition hall and shall not use any device which may damage the hall or cause personal injury. The organizers and local government departments have the right to identify and dispose any exhibits or materials that may cause property damage or personal injury at any time during the exhibition period.

11. Insurance Obligations and Risks

Sponsor should cover insurance for any facility or product delivered to the exhibition hall which may cause any personal injury or property damage and compensate any cost, lawsuit, claim for compensation or other fees to ensure the organizer and exhibition hall will not suffer any damage.

12. Supplementary Regulations

The organizer has the right to issue supplementary regulations for the exhibition, all of which will be part of this agreement and binding on sponsors.
